

TERMS AND CONDITIONS

These Terms and Conditions constitute an agreement between Krishna Ganga Light House (hereinafter referred to as “Light House”/ We/Us) and the Guest (hereinafter referred to as You/Your) “Guest” shall mean any person who has applied (“Applicant”) and have been selected by Light House for attending the yoga and meditation classes (“hereinafter collectively referred to as “Classes”). By coming to Light House, You agree to have read, understood, comprehended and accepted to be legally bound by these Terms and Conditions. This is an electronic record that does not require a physical or digital signature to be created.

PREPERATION:

You understand that this is an intense training devoted to the Art of Spontaneous Meditation (hereinafter referred to as “Kriya Meditation”) and therefore it is mandatory to follow and sincerely practice all instructions in the booklet-Preparation For Kriya Meditation before attending the Class annexed hereto as “Annex-1”.

You understand that You have been selected by Light House to attend the Classes, Hence, Your attendance to these Classes cannot be transferred to any of your family member, relative, friend or anybody else.

CODE OF CONDUCT

Light House is a space for meditation, it is important that You try to remain in silence as much as possible throughout your duration of stay.

You agree to behave in such a way as to create a safe, supportive and learning environment.

You agree not to smoke, drink alcohol or consume any hallucinogenic or banned drug in Light House premises.

You agree not to engage in disruptive speech or behavior. You will comply with all applicable laws and agree not to engage in any form of harassing, offensive, discriminatory or threatening speech or behavior, including relating to race, gender, sexual orientation, religion or disability.

Guests engaging or threatening to engage in such behavior will be requested to leave Light House immediately, and such Guest will not be eligible to receive a refund of any fees paid to Light House.

If You witness such behavior, please promptly inform Light House in order to take appropriate action.

INSTRUCTIONS TO BE FOLLOWED

Please do not use gadgets or speakers in the premises of Light House in high volume or in any manner that may disturb others.

Please do not use mobile phones while walking in Light House. Kindly move to a corner, stand / sit in one place before using the phone.

Please wear appropriate clothes and attend the classes punctually. You may not be allowed to attend the following classes if you miss or drop out of any previous class.

Please arrive at least 5 minutes before the start of each class.

Please sit alone quietly for the duration of the class.

Mobile phones and gadgets are not allowed in the yoga hall.

Yoga mats are provided by Light House, please dress comfortably for yoga and pranayama classes.

Please do not pluck flowers.

MEDICAL DECLARATION:

I, hereby acknowledge and agree to take full responsibility for my health during my stay in Light House.

- a. I agree to provide Light House the full and correct details of all/any of my medical conditions and give full disclosure of any pre- existing or existing disease, medical ailment or injury.
- b. I agree to give brief details about the current status and medication details in the health declaration form during application process of my chronic health problems, such as heart ailments, epilepsy, uncontrolled blood pressure or diabetes, asthma, psychological problems, physical disabilities,

- c. In the event of any emergency or unforeseen health-related complications, I agree to abide by the recommendations made in my best interests by Light House. Any medical expenses incurred in this regard will be fully borne by me.
- d. I agree to indemnify and hold Light House harmless with respect to my health, ailments or recovery during my stay at Light House. Light House shall not be liable and does not hold any responsibility for the same.
- e. I understand that Light House has limited supply/variety of medications and I agree to carry all the regular medications that I would need throughout my stay at Light House, including any and all prescriptive medicines and supplements, adequate for the duration of my stay.
- f. I also agree that in the event of incomplete or false information given by me, I will not be allowed to attend the class or may be asked to discontinue even in the midst of the Class.
- g. I declare that the information I have given is true to the best of my knowledge.

WHO SHOULD NOT APPLY

Pregnant women and women during their menstrual cycle shall not be selected for attending the Classes.

If You have any chronic disease or physical injury.

STAY GUIDELINES

Light House is a space designed for Meditation, health and wellbeing. The rooms are not be used by the Guest as in a hotel, resort, or for casual stay or vacation purposes. They are made available only for the purposes mentioned above.

Light House reserves the right to ask You to leave if, You do not follow the Code Of Conduct, do not follow the Instructions as detailed above, cause damage to the property or any of your activities which is unacceptable to Light House.

While You can share your preference for a particular room, the allocation and the choice of rooms provided to You shall be the sole prerogative of Light

House. You agree to accept the decision without raising any protest or dispute whatsoever.

Except for room cleaning, no other room service is available.

Use Furniture and other amenities provided properly and keep the rooms and washrooms clean.

Please be on time for the meals. Carrying food and beverages to rooms is not allowed.

Please turn off the geyser and other electrical appliances and switches when not in use.

Please seek staff help in case You do not know how to operate any electrical device.

While Light House is a safe space, Guests are advised to ensure safety of their valuables and belongings. Light House will not be held liable for any lost items.

You will be held accountable for any damage caused by You to the property and assets of Light House.

VOLUNTARY ATTENDANCE

You acknowledge and agree that Your attendance in the Classes is voluntary. Since attending any of the Kriya Meditation sessions could involve physical activity by way of yoga, extreme body movements during Kriya Meditation sessions, emotional release by way of crying, howling, screaming, excessive exhaustion due to body pain and emotional upheaval after Kriya Meditations. You agree to assume the risks associated with attending the Class to the fullest extent permitted under applicable law. To the extent permissible by law, You agree to indemnify Us against any and all claims, actions, losses and damages.

You acknowledge and accept that during Kriya Meditation, the Master needs to help You to do certain yoga postures or press specific points in Your body for the Kriyas to happen. If You have any reservations, You shall inform the Master before the start of the Class and refrain from attending the

meditation and Yoga Classes conducted by the Master. You agree to indemnify Us against any and all claims, actions, losses for not being able to attend the class of the Master.

You acknowledge that you are willingly attending the Classes and that you are completely and personally responsible for any outcomes or results. You agree to use your best judgment and due diligence before acting on any knowledge or information obtained from our website or Classes or social media pages or any other material. You acknowledge and accept that Light House is not liable or responsible in any manner whatsoever for any loss or consequence of any specific outcomes or results.

Light House cannot and does not guarantee that you will achieve a specific result or benefit after attending the Classes, and you acknowledge and accept that individual results may vary depending upon the Guest openness, devotion and his or her level of surrender to the divine. Because the results are subject to change and are dependent on a number of factors, no guarantees can be guaranteed. There is no guarantee that using our website, programs, Classes or sessions will result in a specific result.

These Classes are exempt from any representations, warranties, undertakings and guarantees. We make no representations, warranties, undertakings, or guarantees that you will not be injured as a result of attending the Classes, either directly or indirectly or that Your fitness will improve measurably as a result of attending the Classes.

VIDEO, FILMING AND PHOTOGRAPHY

Light House reserves the right to use any photograph/video taken during the Classes in accordance with the Consent Form (Annex-2). A person attending the Classes who does not wish to have their image or video recorded for distribution should make their wishes known to Light House in writing. Any person or organization not affiliated with Light House may not use, copy, alter or modify Light House photographs, graphics, videography or other, similar reproductions or recordings without the advance written permission of Light House.

Video or audio filming and photography of the Classes or talks by Masters by Guests are strictly prohibited.

You shall not disseminate any portion of these Classes to any third party without prior express written permission of Light House.

CANCELLATION AND REFUND

You understand that Light House has to make elaborate arrangements for the Classes well in advance for the Guests to attend yoga class, therapy sessions, food and so on.

No Refund (Cancellation from your end): Subsequent to Your reservation, should You be unable to attend the course, You are welcome to participate in any of the following three sessions. Kindly be advised that the advance paid is non-refundable.

No Refund (Dismissal due to Misconduct or Other Reasons): If, during the course, You are dismissed due to misconduct, violation of our guidelines, or any other reasons that hinder the learning environment for others, no refund will be provided.

100% Refund (Cancellation from Our End): In the unlikely event that we have to cancel the MTC due to unforeseen circumstances You will receive a full refund. We will communicate any such cancellations to You promptly.

If You leave the Classes in between for any reason whatsoever, or refrain from attending either the Yoga or meditation Classes conducted by the Master, You will not be eligible for any refund and We will consider this as cancellation of Your Registration.

There will be no refund for a no – show.

In case You are not allowed to continue the Classes due to medical reasons or Code Of Conduct, no refund can be claimed.

For online payments, the refund will be made by the same mode of payment i.e. via bank account transfer or Secure UPI payments. Please allow up to 4 weeks for the refund to be processed.

Refunds made for offline payments like cash will be made only through NEFT or Secure UPI payments. Please allow up to 4 weeks for the refund to be processed.

LIMITATION OF LIABILITY

In no event will We or Our respective officers, agents, partners, teachers, trustees, founder and employees be liable to You or any third party for any direct, indirect, consequential, exemplary, incidental, special, or punitive damages, including lost profit, lost revenue, loss of data, or other damages arising from Your use of the website and Your attendance to the Classes held by Light House, even if We have been advised of the possibility of such damages. Notwithstanding anything to the contrary contained herein, Our liability to You for any cause whatsoever and regardless of the form of the action will at all times be limited to the charges paid by You for the Classes.

INDEMNIFICATION

You agree to defend, indemnify, and hold Us harmless, including respective officers, agents, partners, teachers, trustees, founder and employees, from and against any loss, damage, liability, claim, or demand, including reasonable attorneys' fees and expenses, made by any third party due to or arising out of Your attendance to the Classes and/or breach of these Terms And Conditions.

FORCE MAJEURE

In the event that it is impossible or impracticable for Light House to proceed with or carry out the Classes in whole or in part, due to any act of God, acts of the government, fire, casualty, flood, earthquake, war, strike, demonstrations, lockout, epidemic, pandemic, destruction of its facilities, riot, insurrection, materials unavailability, or any other cause(s) beyond the reasonable control of Light House and as a result thereof if Light House has to delay, postpone, reschedule, terminate and/or cancel the Class, Light House will not be liable for any losses or damages incurred by the Applicant.

YOUR PERSONAL INFORMATION

As part of application process, Guest must provide a valid government issued ID card (with a photo) such as Aadhaar/ Driving License/Voter ID/ Passport. Guest must present the same ID at the time of check in to Light House.

You consent to the collection and use of Your personal information that You provide in connection with the Classes conducted by Us. We will use Your information to send details and announcements related to the Classes to You. Any personal information that You provide to Us online will be handled in accordance with the laws and regulations of India. We are committed to protecting Your personal information and Your right to privacy. Our Privacy Policy governs the privacy policies of Our Site. You agree that We may use any information that We obtain about You in accordance with the provisions of Our Privacy Policy. Please read Our Privacy Policy carefully as it will help You.

GOVERNING LAW AND DISPUTE RESOLUTION

These Terms And Conditions are governed by the Laws Of India and the Courts in Uttarakhand shall have exclusive jurisdiction in the event of any dispute arising out of or in connection with these Terms And Conditions.
